In consideration for Saint Paul School agreeing to enroll our child(ren) for the 2012-2013 school year, we agree to the following:

- We understand that the \$50.00 re-registration fee per student is non-refundable, and that the first tuition payment for the 2012-2013 school year will be due on May 1, 2012 in full or withdrawn from FACTS .
- We understand that if we withdraw any student between April 13, 2012 and June 15, 2012, we shall be responsible for 25% of the student's 2012-2013 tuition.
- We understand that if we withdraw any student between June 15, 2012 and September 1, 2012, we will be responsible for 50% of the student's 2012-2013 tuition.
- We understand that if we withdraw any student after September 1, 2012, we will be responsible for 100% of the student's 2012-2013 tuition.
- Tuition payments will be administered through the FACTS MANAGEMENT Tuition Payment Program (www.factsmgt.com), which the school will utilize for collecting tuition for the 2012-2013 school year. Information regarding the FACTS Program will be sent to you in the near future.

Saint Paul School is a parochial school and, as such, is dependent on the volunteer efforts of the parents and guardians of our students in order to achieve and maintain our high standards of success. By enrolling our child(ren) at Saint Paul School, we agree to support the school through volunteer hours over the course of the school year and through support of the fundraising activities of the school and Parent-Teacher Organization (PTO).
